Reporting to the AML CTF Manager, the successful incumbent is primarily responsible for supporting and influencing a culture of compliance throughout the organisation, as well as assisting in the management and execution of an efficient Anti-Money Laundering and Counter-Terrorist Financing (AML/CTF) Programme.

Key Accountabilities:

- Ensure that AML Department achieves satisfactory rating from annual audit on areas involving Transaction monitoring.
- Monitoring AML Module of OFSAA and Transaction. Ensure there are no reviews left outstanding in the "Pending Review" queue by end of day on daily basis.
- Perform quality assurance checks to ensure that information on the following registers is performed daily, SMR register, ECDD register, PEP register and HRC register. Ensure maintenance reviews done daily.
- Ensure Periodic Reviews and Trigger Reviews are scheduled and reviewed as per TISA Account onboarding date of anniversary.
- Perform quality assurance checks on all registers that are to be used by AML Technician team for TISA PEP List, HRC List and reporting purposes. Ensure all statistics are reported to AML Manager weekly and monthly for Management report and for BARRC report as well.
- Effective and prompt communication to internal and external customers applying TISA service standard to avoid customer complaints.
- Consistently apply and practice the Code of Conduct as per HR Policy on behavioural management ensuring the values of TISA are practiced.
- Full compliance with the AML CTF Policy including training and passing of an accredited exam.
- Comply with Policies on Anti-Bribery & Anti-Corruption ABC, Conflict of Interests and Gift and Entertainment, Employee Code of Conduct and AML/CTF Department.
